Feed CATTLE SUPREME 8 AUREO2.6 MINERAL GR Medicated at the rate listed below to beef cattle. Cattle under 700 lbs will receive 350 mg of Chlortetracycline daily, and cattle over 700 lb will get 0.5 mg/lb of bodyweight, per day.
