CO-PRODUCT BREEDER MINERAL GRAN can be used as both a free-choice or mixing mineral. Consumption should be 2-3 oz. per head, per day. Dilute with loose salt if consumption is greater than this level.

Caution

CAUTION: Due to the copper level, do not feed to sheep. Follow label directions.

The feeding of supplemental selenium should not exceed 0.3 ppm of total diet. The addition to feed of higher levels of this premix containing selenium is not permitted.
