### Feeding Directions

Feed 1-2 lbs. of 20% RANGE CUBE RU200 Medicated per head per day to mature reproducing cattle to provide 100-200 mg of Monensin daily for Feed Efficiency.

Feed 2 lbs. of 20% RANGE CUBE RU200 Medicated per head, per day to provide 200 mg of Monensin daily to mature reproducing cattle between 1000 and 1400 lbs. of bodyweight for cocci control.

### Caution

**WARNING::** A withdrawal time has not been established for preruminating calves. Do not use in calves to be processed for veal.

**CAUTION:** Do not allow horses or other equines access to formulation containing Monensin. Ingestion of Monensin by equines has been fatal. Monensin medicated cattle and goat feed is safe for use in cattle and goats only. Feeding undiluted or mixing errors resulting in high concentrations of Monensin has been fatal to cattle and could be fatal to goats. Must be thoroughly mixed in feeds before use. Do not feed undiluted. Do not exceed the levels of Monensin recommended in the feeding directions as reduced average daily gains may result. If feed refusals containing Monensin are fed to other groups of cattle, the concentration of Monensin in the refusals and amount of refusals fed should be taken into consideration to prevent Monensin overdosing. The feeding of supplemental selenium should not exceed 0.3 ppm of total diet. The addition to feed of higher levels of this premix containing selenium is not permitted.
