#### **Feeding Directions**

Feed FDLT RECEIVER 5 OXY800 PEL MEDICATED at the rate of 5 lbs. per head, per day to newly weaned or received beef calves 3-5 days preceeding shipment and 3-5 days following arrival in feedlots. FDLT RECEIVER 5 OXY800 PEL MEDICATED provides 2 grams of oxytetracycline daily.

Caution

SPECIAL CONSIDERATIONS: For use in dry animal feed only. Not for use in liquid feed supplements. The feeding of supplemental selenium should not exceed 0.3 ppm of total diet. The addition to feed of higher levels of this premix containing selenium is not permitted.
