Feeding Directions

Feed Performance Creep BT60 Medicated to pasture cattle (slaughter, stocker, feeder cattle and dairy and beef replacement heifers) at the rate of 2 to 6 lb. per head, daily. This feeding level provides 60 to 180 mg of Lasalocid per head daily.

Caution

WARNING: A withdrawal period has not been established for this product in pre-ruminating cattle. Do not use in calves to be processed for veal.

CAUTION: The safety of Lasalocid in unapproved species has not been established. Do not allow horses or other equines access to feed containing Lasalocid as ingestion may be fatal.

The feeding of supplemental selenium should not exceed 0.3 ppm of total diet. The addition to feed of higher levels of this premix containing selenium is not permitted.
